SJI'S CAREER PATHWAYS PROGRAM CONCLUDED IN DECEMBER 2017 AFTER SIX YEARS. THE PROGRAM SUPPORTED LOW-INCOME INDIVIDUALS (200% BELOW THE POVERTY LEVEL) TO EARN COLLEGE CREDENTIALS FOR EMPLOYMENT IN IN-DEMAND SECTORS IN KING COUNTY. OVER THE LIFE OF THE PROGRAM, 1,434 PARTICIPANTS WERE SUPPORTED TO ATTAIN COLLEGE CERTIFICATIONS IN CLASSES IN INTERNATIONAL TRADE AND LOGISTICS, HEALTHCARE, OFFICE OCCUPATIONS AND ADVANCED MANUFACTURING - ALL RANGING FROM TWO TO EIGHT QUARTERS IN LENGTH.
